Arizona Voter Registration Barrier Falls

- Prop 200 passed in 2004
- July 11, 2012 Federal Court orders Arizona election officials
 - Accept Federal Voter Registration form
 - · No documentary proof of citizenship required

*State officials resisting order with new claim

- Dual system sought
- · Would keep barriers in place
- On line systems would likely require documentary proof if permitted
- · Being argued in federal court currently

Arizona Clean Elections Act - update

Corruption and Money in Politics:

- AZSCAM: 1991
 - 13 legislatures indicted on corruption-related charges. (source: AZ republic)
 - · "I sold way too cheap!"
- Post AZSCAM:
 - · Grass root movements:
 - · Public Funding for qualified candidates
 - · Lowering of limits on campaign contribution to candidates
 - · Citizen's Clean Elections Act 1998
- Two legislators removed for campaign finance violations
- Fiesta Bowl, legislative scandals, AG corruption allegations
- SCOTUS decisions
 - "corporations are people" Citizens United
 - "money equals speech" AZ Clean Elections matching funds



The Importance of Clean Elections

Increased Civic Participation and Engagement:

- Prior to Clean Elections contributions concentrated from Paradise Valley, Phoenix Biltmore/Arcadia, Tucson Foothills and out-of-state
- With CE \$5 qualifying contribution requirements campaign contributions now come from all comers of
- 2012 \$5 qualifying contributions must focus on their voters, not donors
 - Arizona Corporation Commission Candidates 1650
 - Legislature 220
- 2010 \$5 qualifying contributions
 - Governor 4410 SoS 2755 AG 2755

 - Treasurer 1650
 - Superintendent of Public Instruction 1650
 - Mine Inspector 550
 - Legislators 220




The Importance of Clean Elections

- For ordinary citizens Clean Elections means a voice in the political process and the opportunity to run for office.
- For Clean Elections candidates Their focus is on voters, not donors.
- For Clean Elections officials They can be independent of special interests and avoid the corrupting influence of raising more campaign cash while passing laws and spending our tax dollars. DO THEY HEAR YOU
- Increased Competition
 - · 1998 24 of 30 State Senate races uncontested
 - 2012 12 of 30 uncontested (in 2010, only 8)
- More women and candidates from outside power and money centers Sen. Jack Jackson Jr - Navajo / Rep. Albert Hale - Navajo / Rep. Sally Gonzales - Pascua-Yaqui



Strengthening Clean Elections Act:



- New competitive funding system
- 2. New Anti-corruption provisions
 - Gift ban
 - Immediate disclosure of donors
 - Big Money spending board or shareholder approval
 - Conflict of interest prohibitions
- AZAN will seek legislators to support these measures in 2013. Ask your candidates if they support the voter approved Clean Elections Act.
