What You Need To Do

Make sure your register system downloads the APL on October 1, 2025. WIC shoppers can purchase the new foods only after the APL is downloaded. Contact your POS provider if you are unsure if your register is using an up-to-date APL.

Approved Infant Formula Suppliers

You must order infant formula from an approved source. The list of approved infant formula suppliers is included with this newsletter.

WIC Food Not Selling?

You may be eligible to stock less than the required amount of one or more WIC foods.

WIC Approved Food

The **Food List** is a booklet that shows you all the food that is WIC approved. WIC approved foods have nutrients the body needs to be healthy. Eating WIC foods improves nutrition and leads to healthy birth outcomes.



New Food List starting October 1, 2025

We updated the Food List! We added and removed some WIC approved products.

The big changes to the Food List are on the next 2 pages.

YOUR REGISTER KNOWS WHAT FOODS ARE WIC APPROVED

Your register will tell you what foods are WIC approved. Registers use an electronic list of WIC approved products called the Approved Product List (APL). The APL controls which products ring up as WIC approved. We frequently add products to the APL. Your register must download the APL daily to keep an updated list of WIC approved products.

WIC Approved Shelf Labels

People who participate in WIC love it when a store uses the WIC approved shelf labels! It makes shopping easier.



You are not required to use the WIC Approved shelf labels. If you choose to use the WIC Approved shelf labels, you need to use them on all the WIC approved products in the same category of food. For example, if you use WIC Approved shelf labels in the cereal section, you need to use it on all the WIC approved cereals.

Stocking Requirements are Changing

THE AMOUNT OF WIC FOOD YOU STOCK MATTERS

To make sure WIC shoppers can use their benefits at your store, we require you to keep WIC food and formula in stock. Beginning on October 1, 2025, the minimum stocking requirements for WIC food and formula will change.

Some of the changes are listed below. See the updated minimum stock requirements included with this newsletter to see all the changes.

- You no longer have to stock whole milk yogurt, but you need to stock more low-fat yogurt
- You no longer have to stock frozen juice
- The amount of 12.4 oz. Similar Advance you have to stock is reduced to 24 cans

Please review them carefully. We may sanction your store if you carry less than the required amounts.

Tell Us About These Changes

You must tell us about changes at least 30 days before they happen. Here are the changes you need to tell us about:

- Ownership
- Physical address
- POS system software and hardware
- Banking management or third party processor
- Hours of operation
- Mailing address

Change of Ownership or Location

Your contract with us is no longer valid if your store changes owners or moves to a new location. You will need to re-apply to become an ITCA WIC authorized store. If a store changes owners or locations without telling us, we take action to get the money back for WIC transactions that happened after the change.

Treat WIC customers the same as other customers



Allow the WIC customer to use as many or as little of their benefits as they'd like



Scan the barcode of each item



Allow coupons and store loyalty programs

Don't...

- X Override any WIC items
- X Substitute WIC items
- X Trade WIC benefits for non-food items, cash, or credit
- Provide cash refunds
 - Publicly identify someone
- X as being on WIC

WIC Benefit Balance

You must allow a WIC shopper to get their benefit balance at the register for free. **Do not** require them to start a purchase to get their balance. If you are unsure how to do a WIC balance inquiry, please ask your store manager or the person who manages your register system.

How to Checkout with WIC

- 1. Scan all items
- 2. Give the mid-transaction receipt to the customer so they can see which foods are covered by WIC
- 3. Remove any food or formula that will not be covered by WIC if the customer asks you to
- 4. Allow the customer to use other forms of payment to pay for any food not covered by WIC
- 5. Give all printed receipts to the WIC customer

Other Things You Need to Know

Returns, Refunds, and Exchanges There is no way to return benefits to the WIC card

IF	THEN
Food or formula is not expired, not spoiled, and has not been recalled	Do not exchange or give a refund
Food or formula is expired, spoiled, or has volume bad	Exchange for the same product
Food item is recalled	Exchange for another WIC item of the same type • An example is exchanging a recalled peanut butter for a different WIC approved peanut butter
Formula is recalled	We will tell you what to do if there is a formula recall

Contact us if you have any questions.

Overcharging WIC

If your store overcharges for WIC products, we may take action to get that money back. We may fine you for the amount you overcharged, or we may adjust the transaction through our payment processor. Before we take action, we will give you a chance to explain the overcharge. If we fine you, you must pay it. We may also end your contract, give you a financial penalty, or both.

Shopping Complaints

Complaints about WIC Customers

If you experience an issue or have a concern about a WIC customer, let us know. You will remain anonymous. People who participate in WIC have agreed to treat store staff with respect and courtesy. You can submit a complaint for any reason but here are some serious concerns we'd like you to report as soon as possible:

- Verbal or physical attacks, threats, and abuse
- Buying, selling, or misusing WIC benefits

Other concerns include:

- Consistently trying to buy the wrong items
- Any mistreatment from WIC customers

Complaints about Stores

If we receive a complaint about your store, we will follow up with you to get more information. We will work with you to resolve the complaint.

Depending on the complaint, we may monitor your store.


Promotional Items

Promotional items are goods or services offered to people to get them to shop at your store. If you offer promotional items to all customers, you must also offer them to WIC customers. Treat WIC customers the same as other customers.



Sanction System

WIC program rules help prevent fraud. They also make sure people who participate in WIC get the full value of participating. Grocery stores are crucial to the success of the WIC program. We hold you responsible for following the terms of your contact with us. When a store does not follow the rules, we may give you a sanction. Sanctions are penalties.



The sanction schedule shows what violations result in penalties. However, the sanction schedule does not include all the rules. You can find all the rules in your contract and in the ITCA WIC Vendor Manual. The sanction schedule is included in this Newsletter.

In accordance with federal civil rights law and U.S. Department of Agriculture (USDA) civil rights regulations and policies, this institution is prohibited from discriminating on the basis of race, color, national origin, sex (including gender identity and sexual orientation), disability, age, or reprisal or retaliation for prior civil rights activity.

The letter must contain the complainant's name, address, telephone number, and a written description of the alleged discriminatory action in sufficient detail to inform the Assistant Secretary for Civil Rights (ASCR) about the nature and date of an alleged civil rights violation.
