THE TRAINING COURSE:

The Inter Tribal Council of Arizona, Inc. (ITCA) is pleased to offer the **Cross-Connection & Backflow Prevention Certification Training Course**. The course is designed to enhance the skills and knowledge of personnel at water utilities on Tribal lands. Subjects covered in this training course will include: principles of backflow prevention, cross-connection control, plumbing codes, inspector and tester responsibilities, as well as repair, troubleshooting, and testing of backflow assemblies. Training course materials will be provided to registrants that are accepted into this course and will be provided at the start of class.

This course helps prepare attendees for the optional *Backflow Prevention Assembly Tester Certification* exams, which will be available for attendees at the end of this course. The certification process is through a third-party, as arranged by ITCA through the registration of this training course. Attendees that are only interested in the training may choose not to take the certification exams.

INSTRUCTOR:

ITCA has contracted with Cross Connection Environmental, LLC to instruct this training course. Cross Connection Environmental, LLC has extensive cross-connection and backflow prevention training experience.

Training course size is limited. Registration for both the course and the certification exams is scheduled to close at the end of the day on **July 12**, **2024**. A later deadline is available for those that are interested in the training course without the certification exam. Registration for just the training course is scheduled to close at the end of the day on **July 17**, **2024**. Please Note: registration is subject to close before this deadline if all class seats are reserved. Registrants that are accepted into the training course will receive written confirmation of a reserve

class seat. Separate written approval is required to be admitted into the certification exam sessions (see Exam & Certification section below).

ATTENDANCE & CONTACT HOURS:

Attendance sign-in sheets will be administered for both morning and afternoon sessions on each day of the training course. All attendees that complete the course requirements will receive written recognition of earned training contact hours based on attendance, participation, and coursework / task assignments. Training contact hours may be accepted towards the training requirements for new certification or as Professional Development Hour (PDH) / continuing education credit towards the renewal of existing certification.

ITCA PROGRAM OBJECTIVE

The National Tribal Water and Wastewater Operator Certification Program at ITCA serves to meet the needs of water utility personnel working on Tribal lands and to provide options for professional certification / credentials that are jurisdictionally appropriate.

EXAMINATION & CERTIFICATION:

As an optional feature of this training course, eligible and approved attendees may take the **Backflow Prevention Assembly Tester Certification** exams (both the written and hands-on practical exams) for <u>free</u> at the end of this training course and at the same location. The exams will be administered by representatives of the American Backflow Prevention Association (ABPA). <u>Participants must have prior written approval from ITCA to be admitted into the examination sessions.</u> Approval for the certification exams is based upon: (1) timely completion of the "**Course** + **Certification Exam**" registration process, which includes additional required information during registration); (2) attendance of the entire training course; and (3) verification exam costs for course participants with prior written approval from ITCA for the examination sessions of this event.

TRAVEL EXPENSE REIMBURSEMENT STIPENDS:

Limited travel expense reimbursement stipends (partial reimbursement) may be available for individuals who are working on Tribal lands and who attend the entirety of the training course. Travel expense cost will be considered for reimbursement on a case-by-case basis and may be subject to funding restrictions. Travel expenses are reimbursed at the federal government GSA rates. The maximum per diem rate for Tempe, Arizona for the time period of this event is \$110 for lodging and \$69 for meals and incidentals. According to federal guidelines, local residents traveling less than fifty miles one-way are eligible only for mileage reimbursement costs for use of privately-owned automobiles at the rate of \$0.67 per mile.

To request a travel expense reimbursement, please submit an *ITCA Travel Expense Reimbursement Claim Form* within <u>fifteen (15) days</u> following the training event. This form is available upon request. The travel expense claim form must include the signature of the attendee's supervisor. ITCA will verify an applicant's eligibility based on event attendance records maintained by ITCA staff.

A registrant that has received seat confirmation from ITCA may request written verification of ITCA reimbursement funds prior to travel. To do so, please submit a completed *Preliminary Application for Travel Reimbursement Stipend Form* to ITCA before your travel to the event. The form must include the signature of the confirmed registrant's supervisor. This form is available upon request. Preliminary applications received five business days prior to the start of the course will be considered on a first-come first-served basis and will be subject to funding availability. Preliminary applications that are approved by ITCA will receive written notice stating the level of funding available for their travel reimbursement.

PUBLIC HEALTH CONSIDERATIONS:

Protection of public health is a top priority and ITCA intends for this event to align with federal and local guidelines and recommendations. As of the date of the ITCA event announcement, June 5, 2024, the COVID-19 County Check website of the Centers for Disease Control and Prevention (CDC), indicated the following.
