#### **THE TRAINING COURSE:**

The Inter Tribal Council of Arizona, Inc. (ITCA) is pleased to offer the **Tribal Utility Management** training course. The course will introduce the concepts of managing small, rural water utility programs and is designed specifically for Tribal utilities personnel that are entering into the water utility management field—such as advancing system operators, new water utility program managers, board members, Tribal administrators and Tribal council members. Subjects covered in this training course will include: regulatory compliance, policy development, financial management, workforce management, worker succession plans, general operations and maintenance, infrastructure master planning, interaction with other entities, public relations, and consumer education. Training reference materials will be mailed to registrants that are accepted into this course.

During the second part of this training course, an optional exam session will be offered for free to allow eligible applicants to take the ITCA **Tribal Utility Management Certification-Level 1** professional certification exam. Attendees that are only interested in the training may choose not to take the certification exam.

#### **INSTRUCTOR:**

ITCA has contracted with subject-matter expert Mr. Michael Alvidrez, of Alvidrez Water Operations, LLC, to instruct this training course. Mr. Alvidrez has extensive experience in the management, as well as the operation and maintenance, of water systems in Indian Country.

A certification exam session will take place during the in-person Part 2 of the training event for those interested in earning the Tribal Utility Management Certification – Level 1 professional certification. *Please be advised that prior approval from ITCA is required for admission into the exam session. There will be no late admission into the exam session.* 

#### ATTENDANCE & CONTACT HOURS:

Attendees that complete the course requirements will receive written recognition of earned training contact hours based on class participation, homework assignments, and attendance. Training contact hours may be accepted towards the training requirements for new certification or as Professional Development Hours (PDH) / continuing education credit towards the renewal of existing certification. Confirmed registrants that are interested in only earning training contact hours may attend as many of the class sessions as needed.

#### **REGISTRATION:** Course Registration Deadline is May 3, 2024

Training course size is limited and offers Priority Registration for Tribal utilities located in the USEPA Region 7 geographic area (including KS, NE, IA, and MO). A General Admission Waiting List Registration is available for Tribal utilities located outside of the Region 7 geographic area. Please Note: a reserved seat does not apply to the exam sessions. <u>Separate written approval is required to be admitted into the certification exam sessions (see below</u>).

#### ITCA PROGRAM OBJECTIVE:

The National Tribal Water and Wastewater Operator Certification Program at ITCA serves to meet the needs of system operators working on Tribal lands and to provide a jurisdictionally correct alternative to state certification programs. The ITCA is a U.S. EPA-approved provider of certification services under the U.S. EPA Tribal Drinking Water Operator Certification Program Guidelines and makes its services available to all Tribal water and wastewater utilities personnel working in Indian Country. ITCA-issued certification in drinking water or wastewater is deemed equivalent and accepted through reciprocity (exam waiver) by numerous states. Tribal operator certification is an additional way by which Tribal governments can exercise their sovereignty and promote their self-determination goals.

#### **EXAMINATION & CERTIFICATION:** Exam Application Deadline is May 16, 2024

ITCA staff will be available to proctor the ITCA standardized 100-question paper-booklet exam following the training course (at the same location) to <u>eligible</u> Tribal personnel seeking Tribal Utility Management – Level 1 Certification. <u>Participants must have prior written approval from ITCA to be admitted into the examination sessions</u>. Approval is based upon submittal of a completed ITCA *Application for New (Tribal Utility Management) Certification* by close of business on **Thursday, May 16, 2024**. Please refer to the ITCA Application Booklet for complete certification eligibility criteria and the application, which is available on the ITCA website or by directly contacting the ITCA Tribal Water Systems Department. You are highly encouraged to submit an application as soon as possible.

Students intending to take the certification exam are encouraged to study the need-to-know criteria, which include lists of recommended study references. #### TRAVEL EXPENSE REIMBURSEMENT STIPENDS:

Limited travel expense reimbursement stipends (partial reimbursement) may be available for individuals who are working on Tribal lands and who attend the entirety of Part 2 of the training course. Travel expense cost will be considered for reimbursement on a case-by-case basis and may be subject to funding restrictions. Travel expenses are reimbursed at the federal government GSA rates. The maximum per diem rate for zip code 66438 in Kansas for the time period of this event is \$107 for lodging and \$59 for meals and incidentals. According to federal guidelines, local residents traveling less than fifty miles one-way are eligible only for mileage reimbursement costs for use of privately-owned automobiles at the rate of \$0.67 per mile. Please note that pursuant to federal government GSA guidelines, participation in provided meals are to be deducted from reimbursement calculations.

To request a travel expense reimbursement, please submit an *ITCA Travel Expense Reimbursement Claim Form* within <u>fifteen (15) days</u> following the training event. This form is available upon request. The travel expense claim form must include the signature of the attendee's supervisor. ITCA will verify an applicant's eligibility based on event attendance records maintained by ITCA staff.

A registrant that has received seat confirmation from ITCA may request written verification of ITCA reimbursement funds prior to travel. To do so, please submit a completed *Preliminary Application for Travel Reimbursement Stipend Form* to ITCA before your travel to the event. The form must include the signature of the confirmed registrant's supervisor. This form is available upon request. Preliminary applications received five business days prior to the start of the in-person Part 2 of the course will be considered on a first-come first-served basis and will be subject to funding availability. Preliminary applications that are approved by ITCA will receive written notice stating the level of funding available for their travel reimbursement.

#### **PUBLIC HEALTH CONSIDERATIONS:**

Protection of public health is a top priority and ITCA intends for the in-person Part 2 of this event to align with federal and local guidelines and recommendations.
